Know all men by these presents that I Sherris Gosnell of Greenville District and State aforesaid for and in consideration of the sum of Ten thousand and sixty four dollars to me in hand paid by Commons Gosnell of the District and State aforesaid have Granted, Bargained, Sold and released and by these presents do Grant Bargain sell and release unto the said Commons Gosnell all that Tract or parcel of land situate in the District of Greenville on the Top of the Great Hogback Mountain and head waters of South Packhill River and the Forks of Saluda Beginning at a chestnut & 3 running thence NW 1/4 ch to a red oak Thence N 74 E 20 ch to a spanish oak Thence N 10 E 7 ch to a pine Thence N 69 E 23 ch to a spanish oak Thence N 58 W 3 ch 50 lbs to a pine Thence S 77 W 9 ch to a spanish oak Thence N 45 W 5 ch to a Hickory Thence N 62 W 14 ch to a forked chestnut Thence S 55 W 24 ch to a Hickory Thence S 15 W 18 ch to a Hickory or pine Thence S 60 W 26 ch to a Red oak Thence S 24 W 3 ch 50 lbs to a Hickory S 58 E 4 ch to a Red oak Thence N 71 E 12 ch to a chestnut Thence S 83 E 12 ch to the beginning chestnut corner & 3 containing in all hundred and eighty six acres more or less together with all and singular the rights members accoutments and appurtenances to the said premises belonging or in anywise incident or appertaining

I have and do hold all and singular the premises aforesaid unto the said Commons Gosnell his heirs and assigns forever and I do hereby bind myself my heirs executors and administrators to warrant and defend defend all and singular the premises aforesaid unto the said Commons Gosnell his heirs and assigns against myself my heirs executors, administrators or assigns against all and singular the claims of every other person or persons whatsoever lawfully claiming or to claim the same in any part thereof
