Rachel Pruitt John Erickson and

Prudence Erickson, of the District of Greenville for and in consideration
of the sum of one hundred and fifty dollars to us in hand paid by these
present of the District and State aforesaid have granted, Bargained sold
and released and by these presents do grant, Bargain sell & release unto
the said Jesse Center to him his heirs and assigns forever a certain
tract of land in the District aforesaid on the waters of Middle
Park of Tyge River called Morgan Creek Beginning at a White
oak corner and running thence W 30 ch. to a white oak Thence N
33 4/4 M ch. 75 links to a Spanish oak Thence N 49 1/2 ch. to a Hickory
on Dautons line Thence N 15 ch. to a Stake in King, Thence N 63 6
2 chs 50 links to a White oak on his corner N with his line about 9
chains to a bunch of chestnut sprouts by King fence Thence an
agreed line N E by a poplar in a low valley upon the road Thence
from said poplar to a hickory sapling by the confluence of a small branch
with the creek straight with the line Thence so to a Spanish oak corner
on James Dawson's line known by Claytons land Thence to the begin-
ning corner being by estimation one hundred and fifty acres more or less
being part of a tract of Land granted to me by patent of 266 acres
bearing date January 6th 1810 including the plantation Rachel Erickson
now lies.

Do agree with all and singular the eight members herein named
appartenance belonging or in any wise appertaining to them and to
hold all and singular the premises mentioned unto the said Jesse Center his assigns
forever and do hereby bind ourselves our heirs executors admitteth every of them to
warrant and forever defend all and singular the said premises unto the said Jesse Cen-
ter against ourselves our heirs and against every person whomsoever lawfully claiming
to claim the same or any part thereof Now witness whereof we have hereunto set our
hands & seals this seven day of December anno d^r c^r eighteen hundred and thirty
