by C. Stearns of Greenville District in the State aforesaid have Granted  
Bargained Sold and Released and by these presents do Grant Bargain  
Sell and Release unto the said C. Stearns all that piece of land and  
Tract of Land situate lying in Greenville District and State aforesaid being  
the Church purchased by me from Samuel A. Towne. A. C. Gill sold as the  
property of Robert Coit deceased with the following corners and distances  
Beginning at a Black Oak tree on the Table Rock road running Thence  
5<sup>th</sup> N 25<sup>th</sup> E Stake 370 Thence 5.20 to a Post oak & Thence S 54<sup>th</sup> W to Stake  
370 Thence S 32<sup>th</sup> E 9.60 to pine 370 Thence N 57<sup>th</sup> E 9.60 to Stake 370 Thence S 30<sup>th</sup>  
29.80 to Stake 370 Thence N 19<sup>th</sup> E Post oak 370 Thence S 33<sup>th</sup> E 12.30 to hickory  
31.00 North Fork of Saluda River Thence along said River to old bridge  
place to Black Gum Stumps near said bridge place on Table Rock road  
Thence N 43<sup>th</sup> W 38.80 to large stones & on your to Gap Creek Thence  
to the beginning corner containing One hundred and eighty acres  
(280) more or less

Together with all and singular the Rights, Members, Her  
editaments and Appurtenances to the said premises belonging or in any  
wise incident or appertaining To have and to hold all and singular  
the premises before mentioned unto the said C. Stearns his heirs and  
assigns forever And I do hereby bind myself and my Heirs Executors  
and Administrators to warrant and forever defend all and singular  
the said premises unto the said C. Stearns his Heirs and Assigns aga  
inst me and my Heirs and any person or persons whomsoever lawfully  
claiming or to claim the same or any part thereof
