In consideration of the sum of Eight hundred and fifty dollars to me in hand paid by Dr W^r S Howell of the State of Missouri having and sold and released and by these presents do grant bargain sell unto the said W^r S Howell a certain piece of land containing Sixty one acres lie the same more or less situated in Greenville Dist^t State of South Carolina lying on the Branches of Saluda River and hath such corner points marks as a plat thereunto annexed beginning on a Stake on the Greenville Columbia Rail Head Thence about 57 1/4 to a Stake 3x5 ft. Then SSW 10 rods to a pine 3x3 ft. Thence 87 ft E 39 1/2 N to a stone 3x3 ft in G^r Brooks line Thence S 34 E 9 1/2 to a pine 3x3 ft. Thence 85 1/2 ft E 17 1/2 to the east line 34 1/2 ft. Thence E 8 chains to the beginning Stake bounded by lands of Garrison McGilly, G^r Brooks, Smallwood & others including all that parcel or tract of land lying on the West side of G^r Brooks being a part of the Silas Holloman Survey This tract includes all the lands within the boundary excepting a piece sixty feet wide running parallel with the R^r which is due to the company if not used by the company then to return to Dr W^r S Howell

Together with all singulars the rights, moneys, precedents, appurtenances belonging or in anywise incident appertaining. To have and to hold all singulars the said premises unto the said W^r S Howell his heirs assigns forever. I do hereby bind myself my heirs Executors, Administrators, to warrant and defend all and singular the said premises unto the said W^r S Howell his heirs Executors Administrators against myself my heirs and against all persons whomsoever lawfully claiming the same or any part thereof the day ninth day One thousand eight hundred and fifty six
