The State of South Carolina  
Know all men by these presents that  
Martin Hunt senior of Greenville  
District in the aforesaid State in con-

sideration of the natural love and affection which I have and bear  
for my son William W Hunt and also for and in consideration of  
the sum of ten dollars to me paid by the said William W Hunt of  
Greenville District in the State aforesaid have given, granted, bargained  
sold and released and by these presents do grant, bargain, sell and release  
unto the said William W Hunt a certain piece parcel and tract of Land  
lying, situate and being in Greenville District and State aforesaid on Salu-  
da river, being the same tract I purchased from the Commissioners  
of Equity of Greenville District sold as the property of Samuel Hunt  
deceased for partition amongst the heirs of the said Samuel Hunt.  
Beginning on the river, running thence N 81 E 7.50 to a Hickory  
thence S 71 E 14.00 to a side Oak, thence N 53 E 17.5 to R.C. thence N 23 3/4 E  
7.5 to a Red Oak, thence N 8 W 37.7 to R.C. thence N 28 W 17. to W.C. thence  
up the branch 24 to sweet gum. thence N 43 1/2 W 3.00 to R.C. thence N 26 1/2  
E 21.00 R.C. thence N 39. W 17.00 to chestnut, at the head of branch. thence  
S 40, W 20. to a white Oak at the head of a branch. thence down the branch  
to the river thence down the Meanders of the river to the beginning Contain-  
ing four hundred acres be the same more or less.

Together with all and singular the rights, members, heredit-  
aments and appurtenances to the said premises belonging or in anywise  
incident or appertaining. To have and to hold all and singular the  
premises before mentioned unto the said William W Hunt his heirs  
and assigns, and against every person or persons whomsoever  
lawfully claiming or to claim the same or any part thereof.
