veyed by Vardry McBee to Gower & Singleton by deed bearing date the sixth day  
of December 1853 Beginning on Green Ingrams corner thence S 68 W 25 3/4 feet  
to a Stake 37 on a Street 40 feet wide thence with said Street N 22 W 500 feet  
to a Stake 37 thence N 68 E 25 3/4 feet to Stake 37 Green Ingrams corner thence  
with Green Ingrams line S 22 E 300 feet to the beginning corner containing 1 A 2  
R 20 P more or less adjoining lands of Vardry McBee and Green Ingrams  
together with all and singular the rights, Members Hereditaments and appurte-  
nances to the said premises belonging or in any wise incident or appertaining  
To have and to hold all and singular the premises before mentioned unto  
the said John A Towns and W A Towns their heirs and assigns forever  
and we do hereby bind our selves our heirs Executors and Administrators  
to warrant and for ever defend all and singular the said premises unto the  
said John A Towns and W A Towns their heirs and assigns against us  
and our heirs or any person or persons whomsoever lawfully claiming or to  
claim the same or any part thereof. Witness our hands and seals this  
ninth day of June in the year of our Lord one thousand eight hundred  
and fifty six and in the eightieth year of the Independence of the United  
States of America
