 W A McDaniel Sheriff aforesaid by virtue of the said writ of fieri facias aforesaid  
 sold to me directed and delivered as aforesaid and by virtue of the Statute in such  
 cases made and provided and for and in consideration of the said sum of  
 Twenty Dollars to me in hand paid or secured to be paid by the said W A  
 Mooney the receipt and payment whereof I do hereby acknowledge have granted  
 bargained and sold and by these presents do grant bargain and sell unto the  
 said W A Mooney his heirs and assigns forever the said tract piece and
