Rolland the 2nd day of December 1870 in accordance with a bond executed by the said S.M. Rolland for the maintenance of said Bastard Child onto her the County families of said Child together with all and singular the rights members Hereditaments and appertinances to the said premises belonging or in anywise incident or appertaining to have and to hold all and singular by said premises unto the said County Commis and successors in office for the above term of Sevelas years to her the County her heirs as above stated I renounce the right to cultivate said Land to Long as said Bastard Child is supported clear of expense to the County of Greenville for the term of Sevelas years above stated then this conveyance to be null and void witness my hand and Seal this 28th day of December in the year of our Lord one thousand Eight hundred and Seventy one and in the twenty fifth year of the Independence of the United States of America Signed Sealed and delivered in the presence of
