 by these Presents that I Geo W  
 Marshall Trustee of Elizabeth H Marshall by virtue of the  
 power in the deed of Trust of Greenville County and the State  
 aforesaid in consideration of Twenty thousand Dollars to me  
 paid by John H Marshall of Greenville County in the  
 State aforesaid have granted bargained sold and released and by  
 these Presents do grant bargain sell and release unto the said  
 John H Marshall his heirs and assigns forever all that  
 House and Land containing fifty acres situate lying and being  
 in the County and State aforesaid on the Rutherford Road one  
 a half miles from the Court House, being the same Land  
 conveyed to me by Waddy Thompson Trustee and Elizabeth  
 Thompson by deeds bearing date 28<sup>th</sup> day of June 1871 and recorded  
 in the Register Messrs Choynance in Book DD and pages 83  
 and 85 reference being had to the said Deeds for the metes & bounds  
 being the same upon which I now reside together with all and singular  
 the Rights Members Hereditaments and Appurtenances to the said  
 premises belonging or in any wise incident or appertaining To have  
 and to hold all and singular the premises before mentioned  
 unto the said John H Marshall his Heirs and Assigns forever And  
 I do hereby bind myself my Heirs Executors and Administrators to  
 warrant and forever defend all and singular the said premises  
 unto the said John H Marshall his Heirs and Assigns against myself  
 and my heirs and every other person whomsoever lawfully claiming  
 or to claim the same or any part thereof Witness my hand  
 and seal the 22<sup>nd</sup> day of November in the year of our Lord One  
 thousand Eight hundred and seventy two and in the Ninety  
 seventh year of the Independence of the United States of
