 B P Gosnell Greenville County  
 I know all men by these presents  
 that I Portman Howard of Greenville County and  
 State aforesaid for the sum of One hundred and fifty  
 Dollars to me in hand paid by Blythy P. Gosnell of  
 the County and State aforesaid do hereby bargain sell  
 and release to the said Blythy P. Gosnell of the County and  
 State aforesaid do hereby bargain to him all that tract of  
 Land lying and being in County and State aforesaid  
 lying on the Knob of the Hog back mountain on the  
 waters of Mill Creek, a branch of South Pacoh.  
 Beginning on a stake on a branch thence N 7 E 37°  
 to a Poplar 3x thence N 81 E 16 chains to a Chestnut Oak  
 3x thence N 1 E 8, chains to a maple 3x thence S 79 E 65  
 chains to a Chestnut Oak 3x thence N 47 E 18 chains to  
 a Chestnut Oak 3x on Bellows line thence along said  
 to the branch thence up said branch to the beginning corner  
 this branch being a conditional line between Gosnell and  
 Bowden supposed to contain One hundred acres more  
 or less together with all and singular the tenements heredita-  
 ments and appurtenances therunto belonging or in any wise  
 incident or appertaining to the said premises or in any way  
 manner I have and to hold to the said Blythy Gosnell  
 & do hereby bind myself my heirs my executors Administrators
