in Greenville County and State aforesaid and
being a part of the tract whereon I now live.

Beginning at a stone and runs thence S. 56. E. 27.0
to a stone 38 Thence S. 8. W. 9. 37. Stone x 3. Thence S 58
E 8.00 Stone thence S. W. 17. 38 Stone 3x Thence N 76
W 9.48 to stone thence N. 8. E. 30. 50 to stone and beg-
inning and containing Twenty and one half acres
be the same more or less. Together with all and
singular the rights, members, hereditaments and
appurtenances to the said premises belong-
ing, or in anywise incident or appertaining
To have and to hold all and singular the premises
before mentioned unto the said Aaron J. Proyles
and to his heirs and assigns forever, and I
