Bryan his heirs and assigns all that piece, parcel or lot of land situated, lying and being in the City of Greenville County of Greenville and State of South Carolina between the streets of Washington and John near the Air Line Railroad Depot containing one acre more or less and hath such marks and bounds as follows: viz: Beginning at a stake on Washington Street, thence 36¹/₂ E 4.95 to a stake on Washington Street, John Street, thence along said street 150¹/₂ N 4.95 to a stake, thence 39¹/₂ W 4.95 to a stake, thence along Washington Street 150¹/₂ E 200 feet to the beginning corner. Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.
