 N. 85° E. 6.15 to a Stake 3x¹, thence S 21° E. 166 to a Stake 3x n thence
 A 65° E. 6.14 to a Stake on said Street, thence along said Street S 20° E. 166 to the beginning corner and containing one acre more or less.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Pre-
 mises belonging, or in anywise incident or appertaining.
