(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Josie D. Hunt his heirs and assigns, all that piece parcel and lot of land situate, lying and being in the City and County of Greenville, in said State. Beginning at a point on the north side of Petegru St. one hundred and five feet from the East side of Manly Street this point formerly being the Hunt & Ebaugh corner of lot known as lot eight block six of survey of the Misses Boyce lands, thence along the Eastern line of said lot eight, N.15 1/2 W. one hundred & fifty 150 feet to Eliza J. McCarters line, thence N.64 E. fifty feet (50) to Mrs. Netherlands line thence a parallel line with the first line above stated to a point on the north side of Petegru St. thence with Petegru Street (50) fifty feet to the beginning corner being a part of the lot bought from T.C.
