



Bright of the State & County aforesaid (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mrs. Sallie U. Ellis and Mrs. Essie G. Bright all that piece parcel or lot of land situated in the City of Greenville & State & County aforesaid on the East side of Pine Street at O.P. Bright's corner thence North with Pine Street 146 feet to E.L. Hanks corner thence East with fence about 80 feet to a wall, being the dividing line thence with fence north East to corner with E.L. Hanks & others (136) feet. Thence South 125 feet with Hammons & others. Thence west 242 feet with Norwood & O.P. Bright's line to the beginning corner on Pine Street.



TOGETHER with all and singular the Rights, Members, Hereditments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

Bright their Heirs and Assigns, against me and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
