(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ethel Lee Williams, all that piece, parcel and lot of land in the City of Greenville, State of South Carolina, and having the following metes and bounds, to wit: Beginning on the north side of a twenty foot street, thence N.86 W. one hundred and fifty (150) feet to a stake in branch; thence up said branch sixty-two (62) feet about N.15 W. to a stake; thence N.82 E. one hundred and ninety-six (196) feet to a stake on a common; thence S.19 W. one hundred and three 1/2 (103 1/2) feet along said common to the beginning corner, containing about one-third of an acre, more or less, and bounded by lands of Louisa Pickens, Tom Davis, and two unknown streets. This is the same lot conveyed to me by M.L. Marchant, deed recorded in R.M.C. office for said County, January 18th, 1887, Book G.S. page 547.
