(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C.J. Pride his heirs and assigns forever all that tract or parcel of land situate lying and being in the County and State aforesaid containing ten (10) acres more or less as follows: Beginning at a stone 3xom on old line, thence N.58 1/2 W.12.25 to stone 3xnm on old line thence S.5 1/2 W.20.00 to stone 3xom, thence N.34 1/2 W.16.38 to the beginning. Also all that other piece parcel and tract of land adjoining the above and containing sixty (60) acres more or less, subject however to an easement over and on a part thereof for backing and standing water granted to the Reedy River Manufacturing Company, said tract having the following metes and bounds, to wit: Beginning on the North Bank of Reedy River and runs N.57 E.28.10 to stone 3x3x3xnm, thence N.33 W. 16.38 to stone 3x3xnm on old line, thence S.57 W. 36.96 passing a hickory to stake 3xnm on said Reedy River, thence with the meanders of said River to the beginning corner.
