(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G. W. Plumley, all that certain piece, parcel or tract of land situate, lying and being in Greenville County, Glassy Mountain Township and State aforesaid, on the north side of South Pacolet River, containing Forty-five acres, more or less, This deed conveys all of the land on the North side of said South Pacolet River and on the North side of Austin Ballew's Mill Creek, which is included in the deed of B. L. Barnett to B. L. Raven bearing date March 26th, 1894. said tract of land containing One hundred and three acres was conveyed to me by D. P. Verner, Master, by deed dated the day of -----  
The whole tract of 10 $\frac{3}{4}$  acres conveyed to me as aforesaid is divided by the two streams above mentioned and the entire portion on the north side only is included in this deed.

TOGETHER with all and singular the Rights, Members, Hereditments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said G. W. Plumley, his Heirs and Assigns forever.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said G. W. Plumley his Heirs and Assigns, against me and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
