Gethold* project, and other boundaries at *Walnut* Hill, *4 1/2* miles west of *Greenville*, running *thence* *E. 65° S. 10, 10, 10 to 36 rods*, *thence* *E. 65° S. 13 to 36 rods*, *thence* *N. 64° E. 112 rods*, *to 36 rods*, *thence* *N. 10° E. 10, 10, 10 to a Survey*, *thence* *E. 74° W. 10, 10, 10 to Beginning*, *339 rods*.
