(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Abner H. Davis of the County and State of Georgia all that lot or parcel of land situated lying and being on the East Side of Court Street, in the City of Greenville, upon which there is an old building, erected by me J. P. Miller on Court Street beginning at the West corner of said building and said Street running thence at right angles with said Street forty and six feet and six inches to the East corner of said building thence East with the East side of said building on a line parallel with Court Street distance six and ten inches to a corner of the building on the East line thence North with the wall of the building at right angles with Court Street distance seven thence East along the East line of the building and parallel with Court Street thirty four feet and five inches to the Eastern corner of said building thence North to and along Court Street thirty four feet and five inches to the Northern end of said line along the front wall of the building with Court Street fifty one feet and three inches to the beginning of the West side of this building and where it end another old building owned by me there is an alley about twelve feet wide which is to be kept open for the joint use of both parties, there is also an alley and part of this building which is to be kept open for the joint use of both parties, there is also an alley and part of this building which is to be kept open for the joint use of both parties.
