 sell and release unto the said Jerry Bowlin all my right title to claim in  
 or to all that certain piece of land situated  
 lying and being in said State and County of Greenville Township  
 adjoining Land of Hubbard Robert Rivers, the Whitmire lands and one  
 a road leading from the Dixie Mountain Road to the Finlay place  
 about one hundred yards from said Dixie Mountain Road and  
 about four miles from Greenville Court House containing two acres  
 more or less, also all that other piece of land or lot of land  
 situated lying and being in said State, County and Township  
 adjoining Land of David Thomas Whitmire and Henry Robert  
 and a road leading from the Mountain Creek Church Road to the  
 old Finlay place about four miles from Greenville Court house  
 and is more particularly described by a Deed recorded in Book C 88
