Beattie, all those pieces of land or lots of land situated on the North Side of North Street in the City of Greenville, State and County aforesaid, bounded by lands of T. D. Morgan and Mrs. G. C. Beattie being the same lots of land convey'd to me by Plaintiff A. Marshall Justice by Deed dated March 24, 1903 and Mrs. G. C. Beattie by Deed dated Aug 20th 1903, and recorded in the Office of the Register of Deeds Conveyance for Greenville County Vol A. D. 6-90 and Vol 111 page 469; and Vol 112 page 228, except that this Deed is not intended to convey to the said Sir W. Beattie the strip of land Deeded to T. D. Morgan by me Dec 30th 1904 fronting two feet on North Street and running along the line of T. D. Morgan to a point on said Morgan line 167 feet from North Street, this strip of land conveyed by me to said T. D. Morgan is fully described in a Deed dated Dec 30th 1904 and recorded in the Office of Register of Deeds Conveyance Vol X page X

TOGETHER with all and singular the Rights, Members, Hereditments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said Sir W. Beattie, her Heirs and Assigns forever.

And I do hereby bind myself my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said Sir W. Beattie, her

Heirs and Assigns, against myself and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
