(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Henry Briggs

All that tract piece parcel and tract of Land containing fifteen and 80/100 (15.80) acres more or less, situate lying and being in Greenville Township in the County and State aforesaid on the South side of the new road leading from the Mowaghan Mill into the Finlay Bridge road about three miles west of Greenville Court House, and having the following metes and bounds, to wit: beginning at a stone 3x3 in said road on said Eastern line and running thence with said line S 66 W 10.90 Ch to a stone 3x0 in J B Martin's Corner thence with said line S 66 1/2 E 27.40 Ch to an Iron pin 3x0 thence N 49 1/2 E 4.50 Ch to an Iron pin 3x0 on said new Road thence with middle of said road 26.00 Ch to the beginning corner, the same being the South Western part of a tract conveyed by R J Hellams to M B Curston 1892 Oct 24 in adjoining lands of J B Martin Mrs Samuel Feaster B F Hughes and Jasper C Martin

TOGETHER with all and singular the Rights, Members, Hereditments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said Henry Briggs and unto his Heirs and Assigns forever.

And I do hereby bind myself my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said Henry Briggs and unto his

Heirs and Assigns, against myself and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
