(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. W. Eagle,

All that piece parcel and tract of land situate, lying and being in the County of Greenville
and State aforesaid, about four miles south of the City of Greenville in Faith Township,
Containing one hundred and sixty-seven acres, more or less, and having the following
lines, corners and boundaries to wit:

Beginning at a rock 3x0 and running thence S. 31° E. 24.40 to a stake 3x0. thence N. 69° E. 55.80 to
the side of Reedy River on the Public Road, thence with the meanders of the river up the stream 5, 15 and 9
chains to a rock 3x0; thence S. 63° 46' 20" to a rock 3x0 the beginning corner, bounded by lands belonging to E.
Earle on the North, by Reedy River on the East, by lands of Dr. W. R. Jones on the South and by lands of the Estate
of H. A. M. Daniel on the West, being the place he buryas the Parkeo Hymead. A right of way lead from the family
grave yard on said place to his residence. Also all that piece, parcel or lots of land, little, & inclosed being in the County
