C. in Vol. 11, Page 121 and filed on the 18th day Dec. 1902, and having the following description: Beginning on stone on Campbell's line and thence N. 77 1/2 E. 16.75 to stone 3x on S. 14 N. 10.80 to a stone in road, thence S. 4 N. 24.50 to a stone on Taylor Chandler's line; thence N. 23 1/2 W. 32.00 to the beginning. Containing twenty six acres, more or less and bounded by lands of J. F. Chandler, Joseph N. Campbell and others
