Dollars, to me in hand paid at and before the sealing of these presents by
M.H. Irvin,

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M.H. Irvin, all that piece, parcel and lot of land, situated, lying and being in Greenville Township and in the County and State aforesaid, within the corporate limits of the City of Greenville and a distance over one mile from the Court House, adjoining lands of H. C. Helen Ladd, land of the Baye Estate and M.H. Irvin and others, and fronting on the Nicholls Town road, containing eight and one quarter acres more or less. Said tract of land is the same that was to me sold and conveyed by Mrs. Anne M. Hind, by deed bearing date April 6, 1904, and duly recorded in the Register's office for the County and State aforesaid, in book L of Deeds at page 634. Said tract of land has the following Bights and bound in courses and distances:—Beginning on a stone 3X N. W. thence S. 48° 40' W. 320' to a stone 3X N. thence S. 27° 12' E. 100' to a stone 3X N. thence N. 50° E. 700' to a stone 3X N. thence N. 30° E. 300' to a wild cherry 3X N. thence N. 33° E. 100' to a stone 3X N. thence N. 67° 30' W. 700' to a stone 3X N. W. thence N. 87° 30' W. 230' to a stone 3X N. thence N. 43° 40' W. 200' to the beginning corner. The foregoing tract of land is the same that was conveyed to the said Mrs. Anne M. Hind by Thomas G. Glemby deed bearing date April 4, 1890 and which has been duly recorded in book XX of affage 640. The description in said two deeds are hereby adopted and made part of this instrument of conveyance.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

Heirs and Assigns forever.And I do hereby bind myself, my wife, my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said M.H. Irvin and to his

Heirs and Assigns, against me and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
