in the State aforesaid, in consideration of the sum of Two thousand, two hundred Dollars, to me in hand paid at and before the sealing of these presents by

T. A. Gilstrap, Jr.

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said T. A. Gilstrap, Jr. two certain tracts of land, one containing three acres to the same more or less as described as follows: Beginning at a hollow stake on Horse Creek thence N. 27 1/2 E. 29.50 chains to a stone 3x thence N. 64 W. 14.50 chains to a stone 3x thence N. 27 1/2 E. 14.50 chains to a stone 3x on Dunklin Bridge road thence with said road to a stake 3x in said road on a line thence S. 27 1/2 W. 34.70 chains to a stake 3x on said creek thence with said creek to the beginning bounded by lands of Anna M. Smith and others it being the same tract of land sold one by J. H. Sullivan in deed bearing date August 20, 1883, and recorded in Vol. 1, page 532 in Register's office at Greenville, S. C. (also one other tract containing seventy-two acres in the same more or less, described as follows: Beginning on a stone on Horse Creek thence N. 28 1/2 W. 8.50 chains to a stone 3x on Dunklin Bridge road thence N. 64 1/2 W. 10.00 chains to a stone 3x thence S. 28 1/2 W. 13.50 chains to a stone 3x thence N. 63 W. 11.87 chains to a stone 3x thence S. 28 1/2 W. 29.50 to a stone 3x on Horse Creek thence S. E. down said creek to the beginning corner bounded by lands of J. H. Sullivan, J. S. Agnew and others, it being the same tract of land sold one by John S. Cannon in deed bearing date June 7th, 1899 and recorded in Register's office for Greenville County in Book 101 Vol. 1, page 824, both tracts being in Dunklin Township, Greenville County, S. C. Now of the last tract I have previously sold to Clinton Wood one acre which will leave seventy-one acres and also I have exchanged 1 3/4 acres with Anna M. Smith cutting off from the 93 acres tract on the S. E. corner fronting with Dunklin Bridge road and adding 1 1/4 acres on the N. E. corner but on the East side of the Dunklin Bridge road fronting tract of Anna M. Smith.

TOGETHER with all and singular the Rights, Members, Hereditments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said T. A. Gilstrap, Jr. & his Heirs and Assigns forever.

And J. S. Agnew do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said T. A. Gilstrap, Jr. & his

Heirs and Assigns, against me and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
