KNOW ALL MEN BY THESE PRESENTS, That We, N. C. Poe and William Wilkins composing the firm of Wilkins, Poe & Company of Greenville, in the State aforesaid, in consideration of the sum of Five Hundred Dollars, to us in hand paid at and before the sealing of these presents by Mrs. Helena G. Croskeys,

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mrs. Helena G. Croskeys: All those two certain lots, pieces or parcels of land in the City of Greenville, County of Greenville, and State aforesaid described as follows: Beginning at the south east corner of Main Street and Stone Avenue, thence with Main St. S. 19 W. 1.57 chains to stake in said St. and corner lot 20: thence with last mentioned S. 73 E. 3.15 chains to stake in line of lot 27: thence with last lot, N. 19 E. 1.71 chains to a stake in Stone Ave.; thence with Stone Avenue N. 73 W. 3.15 chains to beginning corner, being lot #25 on plat of the "Stone Lands" and containing 32/100 of an acre more or less. Also that lot ,piece or parcel of land (adjoining first lot) beginning at a stake on Stone Ave.; 3.15 chains from S.
