The sum of which is hereby acknowledged, here given, received, and admitted, and by due process of grant, bargain, and sale made by Cunningham & Summers, Associates, a General Partnership, its successors and assigns, forever:

All those pieces, parcels or tracts of land aggregating 36.31 acres, more or less situate, lying and being on the southwestern side of South Carolina Highway No. 14 and Bethel Road, on the southeastern side of Bethel Road; and on the southern side of Camelot Drive in Austin Township, Greenville County, South Carolina being shown and designated as Condominium Sites Nos. 1 (A), 2 (B), 3 (C), and 4 (D) on a plat of Holly Tree Plantation made by Enright Engineers dated May 23, 1973 recorded in the RMC Office for Greenville County, S.C. on May 30, 1973 in Plat Book 4-2, pages 36, 37, 38 and 39 and being more particularly described by metes and bounds on Schedule A attached hereto, incorporated herein by reference and made a part hereof as though fully set forth herein.
