NOTICE IS HEREBY GIVEN, THAT

WILLIAM H. WARD CLAYTON TILE COMPANY

is due the sum of One Thousand Seven Hundred Thirteen and 75/100 (\$1,713.75) Dollars from plus costs, expenses and reasonable attorney's fees, from JOHN F. DAY and or WILSON ROAD according to a statement of a just and true account of said indebtedness, with all just credits given, being attached hereto and made a part hereof, together with interest from the 20th day of June, 1975.

That said debt is due the undersigned for labor performed or furnished, and/or for materials furnished, and actually used in the erection, alteration or repair of buildings or structures situated on, or in otherwise improving, the real estate hereinafter described, by virtue of an agreement with, or by consent of, JOHN F. DAY, owner, and WILSON ROAD, contractor, the owner thereof, or a person or persons authorized by, or rightfully acting for, said owner; or said debt is due the undersigned because such improvements have been authorized by said owner. That, as shown by the attached statement, the undersigned labored on, or furnished labor and materials for, such buildings, structures, or improvements, within ninety days of the date hereof, to wit, on or after the 20th day of June, 1975.

That by virtue thereof, by the service and filing of this Notice and Certificate, and pursuant to the provisions of the Statutes in such cases made and provided, the undersigned has and claims a lien to secure the payment of the debt so due and the costs of enforcing said lien upon the buildings or structures herein above mentioned and upon the following described real estate:

ALL that certain tract of land containing 11.46 acres, more or less, in Butler Township, in Greenville County, State of South Carolina, lying southwest of Roper Mountain Road; bounded now or formerly as follows: North by Roper Mountain Road; East by lands of John F. Day; South by lands of A. H. Rosmond; and West by lands of John F. Day; said tract of land being more particularly described according to the plat of survey entitled "Survey for John F. Day" prepared by Carolina Surveying Company on April 17, 1974, and revised on August 16, 1974, and November 18, 1974, as follows:

BEGINNING at an iron pin in or near the center line of Roper Mountain Road (said iron pin being located 1550.5 feet in a northwesterly direction from the intersection of the center line of Moore Road with the center line of Roper Mountain Road) and running thence S. 35-30 W. 924.3 feet to an iron pin on the line of property now or formerly belonging to Rosmond; thence along the Rosmond line, N. 70-24 W. 521.5 feet to an iron pin; thence along the line of property now or formerly belonging to John F. Day, N. 35-35 E. 1038.4 feet to an iron pin in the approximate center of Roper Mountain Road; thence along Roper Mountain Road, S. 54-30 E. 500 feet to an iron pin, the point of beginning. Said lands are a portion of the same lands described in that certain deed from Virginia B. Mann to John F. Day, recorded in the REC Office for Greenville County, S. C., in Deed Book 921, page 54.
