ALL that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville within the corporate limits of the City of Greenville, being known and designated as Lot No. 28 and the southernmost part of Lot No. 27 of a subdivision known as Stone Lake Heights, Section No. 4, as shown on plat thereof prepared by Picmont Engineers & Architects July 8, 1964, revised October and December, 1965, recorded in the R.M.C. Office for Greenville County in Plat Book EBB, at Page 159, and having, according to said plat, the following retes and bounds, to-wit:

BEGINNING at an iron pin on the northerside of Ashford Avenue, joint front corner of Lots Nos. 28 and 29, and running thence along the joint line of said lots and continuing along the joint line of Lots Nos. 27 and 29 (following the approximate center of a 10-foot drainage easement) N. 27-10 W. 160.3 feet to an iron pin in the center of the rear line of Lot No. 27; thence along the line through the center of Lot No. 27, S. 57-58 W. 159.3 feet to an iron pin on the eastern side of Wayne Street; thence along the eastern side of Wayne Street, S. 27-46 E. 154.7 feet to an iron pin; thence following the curvature of Wayne Street as it intersects with Ashford Avenue, the chord being S. 78-46 E. 31.4 feet to an iron pin on the northern side of Ashford Avenue; thence along the northern side of Ashford Avenue, N. 50-14 E. 135.0 feet to the Beginning Corner.
