EXHIBIT A

ALL THAT TRACT OR PARCEL OF LAND lying and being in Greenville County, South Carolina, and being more particularly described as follows:

To find the True Point of Beginning, commence at the point of intersection of the centerline of Laurens Road, having a 120 foot right-of-way width, and the centerline of Verdae Boulevard, having a variable right-of-way width; run thence North 05°00'53" West a distance of 175.57 feet to an iron pin old on the eastern right-of-way line of Laurens Road, said iron pin old being the TRUE POINT OF BEGINNING. From the True Point of Beginning as thus established, run thence along said eastern right-of-way line North 25°04' West a distance of 801.8 feet to an iron pin old; thence leaving said right-of-way line, run along the southern line of property belonging to Big "O" Dodge, North 65°33' East a distance of 443.5 feet to an iron pin old; thence run along the western line of property belonging to Verdae Properties, South 25°00' East a distance of 45.2 feet to a point; thence run along the southern line of property belonging to Verdae Properties, North 64°52' East a distance of 190.0 feet to a point; thence run North 75°48' East a distance of 424.6 feet to a point; thence run South 64°09' East a distance of 205.0 feet to a point; thence run South 17°09' East a distance of 201.7 feet to a point; thence continue South 51°12' East a distance of 212.4 feet to a point; thence run South 17°00' East a distance of 375.3 feet to a point on the northern right-of-way line of Verdae Boulevard, said right-of-way having a width of 80 feet at this point; run thence along said right-of-way line South 78°47' West a distance of 130.6 feet to an iron pin old; thence run South 78°33' West a distance of 25.3 feet to an iron pin old; thence continue South 77°25' West a distance of 101.0 feet to an iron pin old; thence run South 75°36' West a distance of 101.2 feet to an iron pin old; thence run South 71°46' West a distance of 101.2 feet to an iron pin old; thence run South 71°37' West a distance of 101.2 feet to an iron pin old; thence continue South 70°08' West a distance of 101.2 feet to an iron pin old; thence run South 68°18' West a distance of 101.3 feet to an iron pin old; thence run South 66°29' West a distance of 131.3 feet to an iron pin old (said right-of-way of Verdae Boulevard having a width of 80 feet at this point); thence continue South 68°46' West a distance of 330.9 feet to an iron pin old (said right-of-way having a width of 110 feet at this point); thence run North 78°00' West a distance of 155.6 feet to an iron pin old on the eastern right-of-way line of Laurens Road, said iron pin old being the TRUE POINT OF BEGINNING.
