certain tract of land in said State and County, Chick Springs Township, about four miles northwest
Greenville, S.C., being bounded on the northeast and north by lands formerly of F.O. Copland Estate
now lands of Ed Mason and Tom Young, on the east by lands formerly of F.O. Copland Estate and on
the southwest lands now or formerly of McAnally, and being a part of tract No. 4 as shown on
plat of the property F.O. Copland Estate, made by F.O. Copland, Surveyor, Decr. 5th, 1918, and has
