

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, H. N. Jullis
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, *I*, the said *H. N. Jullis*
in and by *I* certain note or obligation, bearing date the *9th* day of *January* 192*9*
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *seventy-five hundred (\$2500.00)* Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly from the *9th* of *January* A. D. 192*9*
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
the said *H. N. Jullis* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *February* 192*9*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *thirty-nine + 58/100 (\$39.58)* Dollars,
being the regular monthly installment payable on the *twenty-five* Shares of Stock and *fourteen + 58/100 (\$14.58)* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *thirty-six + 67/100 (\$36.67)* Dollars, (*25.00* Dollars, being the regular monthly payment on said stock and *Eleven + 47/100 (\$11.47)* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *thirty-three + 75/100 (\$33.75)* Dollars, (*25.00* Dollars, being the regular monthly payment on said stock and *Eight + 75/100 (\$8.75)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *thirty + 83/100 (\$30.83)* Dollars, (*25.00* Dollars, being the regular monthly payment on said stock and *Five + 83/100 (\$5.83)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *twenty-seven + 91/100 (\$27.91)* Dollars, (*25.00* Dollars, being the regular monthly payment on said stock and *Two + 91/100 (\$2.91)* Dollars, being the monthly interest on balance due.)
Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said shares of stock and the certificate thereof, the amount at such time paid, shall be credited as a payment upon the advance or loan made, the said

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto *me* the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

in Greenville Township, being a part of Lot Nos. 35 and 36 as shown on a plot of the subdivision known as Sans Souci Villa, recorded in Public Book A, at page 510, and the said lot having the following metes and bounds, to-wit:
Beginning at a point on Brogan Street at the corner of Lot conveyed to W. L. Lucas by Sam McEwan and thence running N. 10-30 E. 62 feet; thence S. 57-25 E. 175 feet; thence S. 10-30 W. 62 feet; thence N. 57-25 W. 175 feet to the beginning corner.
