

## THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

*We, Rose Bramlett and Edith Bramlett*

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *we*, the said *Rose Bramlett and Edith Bramlett*, in and by *our* certain note or obligation, bearing date the *16th day of November 1929*, indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *\$1,650.00* Dollars, with interest thereon at the rate of *6% per centum per annum*, payable monthly from the *16th day of November 1929*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that *we*, the said *Rose Bramlett and Edith Bramlett*, shall pay or cause to be paid to the said Company, or to certain attorneys, successors or assigns, at Greenville, *South Carolina*, aforesaid, monthly, on the *20th* or before the end of the month of *November 1929*, and on the *20th* or before the end of each month thereafter for twenty successive months, the sum of *\$165.00* Dollars, being the regular monthly installment payable on the *16th day of November 1929*, *Shares of Stock and Capital \$1,650.00 + \$311.00 (\$2,063)* Dollars, being the monthly interest on the advance or loan); until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Twenty six dollars and 77 cents (\$2.77)* Dollars, being the regular monthly payment on said stock and *Interest \$2.77* Dollars, being the monthly interest on balance due; for the next twenty months the sum of *Eighty five dollars and 85 cents (\$0.85)* Dollars, being the regular monthly payment on said stock and *Interest \$0.85* Dollars, being the monthly interest on balance due; for the next twenty months pay the sum of *One dollar and 65 cents (\$1.65)* Dollars, being the monthly payment on said stock and *Interest \$1.65* Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the *20th* or before the last day of each month, and shall thereafter surrender to the Company, *one share of stock and the certificate thereof, the amount at such time paid shares by *Rose Bramlett* to be credited as a payment upon the advance or loan made*. *Rose Bramlett and Edith Bramlett* and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against, *us*, the said *Rose Bramlett and Edith Bramlett*, and *Edith Bramlett*, in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition hereunder written, reference being thereto had will more fully appear.

NOW, KNOW ALL MEN THAT, *we*, the said *Rose Bramlett and Edith Bramlett*, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *the said*, the said *Rose Bramlett and Edith Bramlett*, in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

*in the hill of Rutherford, having front on the south side of Rutherford Street, running thence west side of Rutherford Street, thence northwardly along Rutherford Street to a stake L. 76-15 W. 131 feet more or less to the corner of a fence post; thence N. 17-57 E. 20 feet more or less to a stake in line of Rutherford Street, thence N. 17-57 E. 23.8 feet to a stake at corner of said alley; thence with said alley N. 78-40 E. 123 feet to Rutherford Street, the beginning corner. This is the same tract of land described in a Deed from *Rose Bramlett and Edith Bramlett* to *Lucia King*, by deed of *Robert S. King*, dated *Dec. 1, 1929*, Notary Public for South Carolina, recorded to said Edith Bramlett date to be recorded.*
