WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of Four Thousand Three Hundred and no/100
(\$4300.00) Dollars, money loaned this day, with 8 1/2 interest thereon from this date at the rate of eight per cent. per annum, payable weekly,

the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to wit:

On Lawton Avenue in Ward Five of the City of Greenville, and having the following description and boundaries to-wit:
Beginning at a point on west side of Lawton Avenue 141.3 feet from Douthitt Street, corner of Lot of Mrs. Ida Chambers, and running thence in a westerly direction along lines of Lots 1, 2 and 3, 174 feet; thence in a line parallel with Lawton Avenue 50 feet to the point on line of lot of J. B. Aiken; thence along line of J. B. Aiken 173 feet to a point on Lawton Avenue; thence along west side of Lawton Avenue 50 feet, more or less, to the beginning, corner being the same lot of land conveyed to St. J. Martin by J. L.
