WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of

Dollars, money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly,

the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to wit:

All that lot of land situated on Bureton St., near the City of Greenville in the County and State aforesaid, being one-half of lot No. 7 as shown in Plat Book 7, at page 813 and this is the Eastern half of said lot. Beginning at a stake on Bureton St., 150 feet from the corner of lot No. 6 and runs thence with said Street N. 58° 19' E. 50 ft. to corner of an unnamed street, thence along said street S. 25° 51' E. 199.8 feet, thence S. 53° 52' W. 35 feet, thence in a straight line 201.55 feet, more or less, to beginning corner.

Also all my right, title and interest in a 15 foot alley, see deed recorded Volume 88, page 542.

You value I hereby waive the priority of the mortgage to me by W. L.
