\$20.00 to be paid on the 25th day of November, 1937; \$25.00 on the 25th day of February, 1938; \$25.00 on the 25th day of May, 1938; \$25.00 on the 25th day of August, 1938, and the sum of \$50.00 on the 25th day of November, 1938; \$60.00 on the 25th day of February, 1939; \$70.00 on the 25th day of August, 1939, thereafter up to and including the 25th day of May, 1942, and the balance of the principal on the 25th day of August, 1942;

with the privilege for the borrower to make additional payments on the account of principal on any interest date up to \$50.00

with interest thereon from the date guaranteed on the 25th day of November, May and August, annual of the at the rate of 5 1/2, 6 1/2, 7 1/2, 8 1/2, 9 1/2, 10 percent. per annum, to be computed and paid in each year until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount so unpaid by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and in case said note after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity, it should be deemed by the holder thereof necessary for the protection of its interest to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including attorney's fees, to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

C. in Plat Book E, page 37, the following lines and bounds, to wit:-

Beginning at an iron pin on the West side of Jones Avenue at the joint corner of Lots 51 and 52, and running thence with the West side of said Avenue S. 00-50 E. 70 feet to an iron pin, joint corner of Lots 52 and 53; thence with the joint line of Lots 52 and 53 N. 87-28 E. 108 feet to an iron pin, thence N. 46-21 E. 78 feet to an iron pin, thence N. 16-08 E. 14.8 feet to an iron pin, joint rear corner of Lots 51 and 52; thence with the joint line of said lots S. 89-10 E. 164.7 feet to an iron pin on the West side of Jones Avenue, the beginning corner.
