as follows: The sum of Seventy-five (\$75.00) Dollars to be paid on the principal on the 25th day of May, 1938, and the sum of Seventy-five (\$75.00) Dollars on the 25th day of August, November, February and May of each year thereafter, up to and including the 25th day of November, 1947, then the balance of the principal remaining unpaid on the 25th day of February, 1948.

with interest thereon from late May 1st 1938 at the rate of six (6%) per cent. per annum, to be computed and paid quarterly May 1st, August 1st, February 1st, May 1st on the 25th day of May, August, February, May in each year until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including

We do say that a certain piece, parcel or lot of land situate, lying and being on the north side of East North Street, in the City of Greenville, County and State aprevaied, and being, according to a plat thereof prepared by Balton & Hedges, Engineers, March, 1927, the following metes and bounds, to app:
