at the rate of six (6%) per cent. per annum,

to be computed and paid on the same date as the principal, and if any portion of principal or interest is at any time due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and enforce this mortgage; and in case said note, after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity, it should be placed by the holder thereof necessary for the protection of its interests to place, and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including the cost of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or tract of land in the County and State aforesaid in Haute Township, being known and designated as Tract No. 2 as shown on plat of property of E. A. Smyth, et al., made by Dalton + Jones, November, 1935, which plat is recorded in the P. M. C. Office for Greenville County in Plat Book D at page 178, and having according to said plat the following metes and bounds, to-wit:
