All that piece, parcel or lot of land in Greenville Township
state and county aforesaid, *being a strip of land about one half mill from*
Woodside Mills, and being *part of* designated as lot # 7
and part of lot # 8 on a plat of a subdivision known as
East Summit View, a plat which is recorded in R. M. C. office
for Greenville County in plat book A at page 389, said lot
having the following metes and bounds:
Beginning at a point on the New Cut Road, corner of lots
6 and 7 and running thence *with the line of lots 6 & 7* ninety-eight feet
(98) to the corner of lots *nos. 3 & 2* sixty-seven feet (67.6) ten feet
beyond the line of lot *no. 8* one hundred twenty-five feet (125.5) more or
less to the New Cut Road, thence along New Cut Road sixty-one
and five-tenths feet (61.5) to the beginning corner, containing
