WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of

money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly, the payment whereof the said party of the first part is
anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him, in hand paid, the receipt whereof is hereby acknowledged, the said
party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that
certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

On the west side of River Street, in the City of Greenville, and hav-
ing according to a plat thereof prepared by C. M. Furman
Jr. Eng., Oct 28, 1926, the following metes and bounds, to-wit:
Beginning at an iron pin on the West side of River Street,
which pin is 85.8 feet North of Rhett Street, and running
thence along the West side of River Street N. 2-58 E. 60.8 feet
to a pipe in line of Berry property; thence along line of Berry
property S. 79-13 W. 181.7 feet to an iron pin; thence S. 16-30
E. 56.5 feet to an iron pin in line of other property of Second
Presbyterian Church; thence along line of said property N.
80-16 E 161.7 feet to the point of beginning.

All that certain piece, parcel or lot of land situate, lying
and being in Greenville County, State aforesaid, on the North
side of Rhett Street in the City of Greenville, and having the
following metes and bounds, to-wit:

Beginning at a stake on Rhett Street at corner of Lot for-
merly owned by J. F. Mackey, and running thence N 70 3/4 E,
51 feet to a stake at the corner of the lands of the Second
Presbyterian Church; thence N. 20 W. 232 feet to stake on
lot owned by Walter M. Scott; thence with his line S. 70 3/4
W. 70 feet to a stake; thence S. 20 E. 234 feet and 5 inches
to the beginning corner on Rhett Street, and being the
same lot conveyed to the Second Presbyterian Church by
James N. Berry by deed dated Dec. 3, 1919 and recorded in
the R. M. C. Office for Greenville County in Vol. 55, page 102.
