WHEREAS, *L. Mrs. Lola L. Smith*, in and by..... certain..... note.... in writing, of even date with these presents, *ans.* well and truly indebted to.....

with interest thereon, from..... *date* at the rate of..... *8* per cent. per annum to be computed and paid..... *annually*.

..... until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note.... to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of..... *Lucky Dollars*.

..... besides all costs and expenses of collection, to be added to the amount due on the said note.... to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note...., reference being thereunto had, as will more fully appear.

..... in hand well and truly paid by the said..... *Mrs. R. L. Ford*, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bar-

All that certain piece, parcel and lot¹ of land situate, lying and being in the State and County aforesaid, near the town of Greer, and lying between the New and Old National Highway, beginning at an iron pin West side of old Highway and running thence S. 2-25 W. 116.3 feet to an iron pin near new Highway; thence S 87³/₄ W. 86.6 feet to an iron pin on new Highway; thence N. 12-10 E. 152.5 feet to an iron pin on edge of old Highway; thence S. 61-40 E. 69.7 feet to beginning containing a fraction of an acre, more or less, being a portion of the lots conveyed to R. L. Ford and Lola L. Smith by J. M. Linley, deed recorded Feb. 14th, 1920, at page 461, in Book "H". Bounded on West by R. L. Ford and others. Surveyed by W. A. Christopher, Surveyor, May 17th, 1920, and is also part of lot 8 on above mentioned plat which was conveyed to R. L. Ford by J. C. Cunningham in deed recorded Sept. 15th, 1919 in Book "H", Page 454.

It is agreed that the rents from the property described above shall be applied monthly to the payment of the said note from January 1st, 1932.
