All that certain piece, parcel or lot of land situate, lying  
and being just beyond corporate limits of the city of  
Greenville, County and State aforesaid, on North Main  
Street ~~opposite~~ ~~south~~ extension, Beginning  
at a point 380 feet from the N. E. corner of Kenwood  
Avenue, thence along N. Main St. extension 201 feet to a  
point, thence in S. E. direction 175 feet to a point, thence  
in S. direction approximately 30' to a point, thence in a  
S. E. direction approximately 500' to line of Garroux property,  
thence along line of said property 167.5 feet to corner on  
new street (not yet named), thence along said unnamed  
street approximately 675 feet to the initial corner on N. main  
St. extension, comprising three lots on N. main St. exten-  
sion 67 feet by 175 feet and eight lots on the new unnamed  
street (seven exactly 60 feet by 167.5 feet and one next to
