AND IT IS AGREED by and between the said parties, that I am to hold and enjoy the said premises until default of payment shall be made.

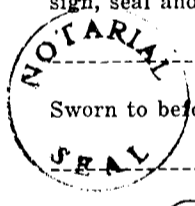
