all that tract or lot of land in *Greenville* Township, Greenville County, State of South Carolina, just outside the city limits of the City of Greenville, being lots number twenty and twenty-one as shown on plat of the Hammett Estate, as shown on *Greenville Plat* made May 14, 1900, recorded in M. B. office of Greenville County, each of said lots fronting 100 feet on *Pine Street* and running back 150 feet to an alley, (now *Mulberry Street*) and each containing 44/100 acres, more or less, being the same this day conveyed to the said M. B. Bradley, by E. L. Mann, "actor for Greenville County, South Carolina," to be recorded, and this mortgage being given to secure the payment of the balance of the purchase price of said lots of land.

It is understood and agreed that the rents on the property above described shall be collected by the mortgagors and shall be credited on the note hereby secured, as additional payments to the monthly payments above stipulated, but the mortgagors shall not be liable to account for more than the rents collected, less costs of collection.
