NOW KNOW ALL MEN, That *I, the said J. M. Lockaby and Emma Bridges*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained,

sold and released, and by these presents do grant, bargain, sell and release unto the said *M. P. Cantrell* all those two tracts of land belonging to the mortgagor *Emma Bridges* as follows:

*All that piece parcel and tract of land situate in Bates Township, County and State aforesaid, adjoining lands of J. M. Ferguson, Jerry Hawkins and others and having the following metes and bounds, to-wit: Beginning on a S.O. stake N.E. 21/4, thence up a road N. 69 3/4 W. 7.50 to iron pin in road; thence S. 2 3/4 E. 25.50 to a stake N.M. thence N. 70 1/4 E. 9.84 to a stone 40 W; thence N. 49 1/2 W. 19.78 to a stake 20 W; thence N. 61 1/4 E. 3.81 to a stone 0 W; thence N. 2 1/4 W. 10.10 to the beginning corner and containing 16 1/4 acres more or less.*

*Also, all that other piece parcel and tract of land lying and being in Bates Township, County and State aforesaid, adjoining lands of W. H. Benson, P. S. Poole and others. Beginning on a stake S.E. corner; thence running N. 3 5/8 W. 12.65 to a stone 0 W on road; thence up the said road N. 86 W. 8.58 to a stake 0 W; thence S. 9 E. 14.40 to a stone N.M.; thence N. 83 E. 7.00 to the beginning and containing 10 1/2 acres, more or less. Being the same two tracts of land conveyed to the mortgagor Emma Bridges by Pauline L. Harris by deed dated July 1, 1913 and recorded in R. M. C. Office for Greenville County in Vol 27, page 573, R. *All that certain tract of land situate in Bates Township, County and State aforesaid, about 13 miles north of Greenville County Court House, and having the following metes and bounds, to-wit: Beginning at an iron pin on the south side of a road, and running thence due north 2.40 to a stake, thence S. 7 E. 4.00 to R.O., thence S. 8 1/4 W. 17.30 to a stone, thence S. 20 E. 4.92 to stone; thence N. 70 1/4 E. 5.75 to a stone; thence N. 2 3/4 W. 25.20 to an iron pin on a road; thence N. 69 3/4 W. 4.07 along said road to the beginning corner, and containing 13.29 acres, more or less. Being the same tract of land conveyed to the mortgagor herein by W. E. Hart by deed dated Dec 14, 1919, and recorded in the R. M. C. Office for Greenville County in Vol 48 at page 25.*

*Also, all that certain piece parcel or tract of land situate in Bates Township, County and State aforesaid, adjoining lands of E. M. Hawkins and others. Beginning on a stone northeast corner; thence running S. 41 3/4 E. 5.00 to an iron pin; thence S. 75 W. 7.93 to an iron pin; thence N. 33 1/2 W. 4.11 to an iron pin; thence N. 70 1/2 E. 6.95 to the beginning corner and contains three acres. Being the same tract of land conveyed to the mortgagor herein by J. M. Ferguson by deed dated May 14, 1921 and recorded in the R. M. C. Office for Greenville County in Vol 49, at page 460.*

*Less, however, 7 1/2 acres heretofore conveyed by Emma Bridges to L. S. Poole, which deed being recorded in Vol 43 at page 344, R. M. C. Office for Greenville County, and 2 3/100 of an acre conveyed by the said Emma Bridges to E. M. Hawkins, et al, which deed is recorded in Vol 82, at page 64, R. M. C. Office for Greenville County. Also less a lot 167 feet by 30 feet conveyed by J. M. Lockaby to School District*
