Beginning at an iron pin on the Old Rutherford Road and running thence N. 0-23 W. 245.5 feet to an iron pin; thence N. 80-23 W. 310 feet to an iron pin; thence S. 54-29 W. 207 feet to an iron pin; thence S. 28-08 E. 306.5 feet, more or less, to an iron pin on the Rutherford Road; thence N. 67-07 E. 82.7 feet to an iron pin; thence N. 76-07 E. 245 feet to the beginning corner.
