All that piece, parcel or lot of land situate, lying and being in Ward Two of the City of Greenville, County of Greenville, State of South Carolina, on the East side of Manly Street, between Pettigru and Washington Street, and having, according to a plat thereof prepared by C. M. Firman, Jr., Engineer, on September 24, 1924, the following metes and bounds, courses and distances: Beginning at a stake on the East side of Manly Street, corner of Dr. C. H. Fair's lot, which point is 180 feet in a southerly direction from the intersection of Manly Street with Pettigru Street, and running thence with Manly Street, S. 14° 34' E. 80 feet to a ten-foot alley; thence with the North side of said alley and with the line of the property of Marion Brawley, N. 75 E. 175 feet to a stake on line of property of Allen J.
