Whereas, I, Martin F. Cusei,

SEND GREETING:

in and by myself certain promissory note in 93 of Greenville, S.C., note in writing, of even date with these presents, it is well and truly indebted to Peoples National Bank of Greenville, S.C., in the full and just sum of Eleven thousand dollars and Eighty-eight Dollars to be paid one year after date of day, being the 1st day of July, 1881, plus the principal and interest thereon from at the rate of 7 per cent. per annum, to be computed and paid until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of five percent besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

is hereby acknowledged, have granted, bargained, sold and released by these Presents do grant, bargain, sell and release unto the said

Peoples National Bank of Greenville, S.C.
All that piece, parcel and lot of land situated, lying and being on the City of Greenville on the west side of North Main Street and hath the following metes and bounds, to wit:

Beginning on an iron pin corner of my lot and lot now or formerly owned by N. C. Cole on the west side of N. Main street and running thence along the line of said N. C. Cole's lot in a westerly direction 243 feet more or less to an iron pin corner of my lot and lot now or formerly owned by Mrs. L. C. Wood, thence along the line of said lot in a southerly direction 105 feet more or less to an iron pin corner of my lot and lot now or formerly owned by Dick Jones, thence in an easterly direction 243 feet more or less to an iron pin on North Main Street, thence along the western side of N. Main Street in a northerly direction 115 feet more or less to the beginning corner being part of the lot conveyed to me by L. L. Harrell by deed dated April 20th, 1880.

L. Harrell April 20, 1880.
